Elective courses

- *In place of the electives (E), a maximum of 18 ECTS can be chosen in other master programs at the Faculty of Economics and Business and/or MScF programs in other Swiss universities. Approval of the Director of the MScF is mandatory.*
- *In addition, 6 elective ECTS can be replaced by an internship of at least 6 weeks including the writing of a report supervised by a professor of the Faculty of Economics and Business. Approval of the Director of the MScF is mandatory.*
- *In addition, 6 elective ECTS can be replaced by passing the CFA level I exam.*

E: exam during the exam session at the end of the semester

EI: evaluation organized during the semester

Retake exam after 1 failure: 2h written exam during the exam session at the end of the semester or the September session.

Retake exam after a justified absence: 2h written exam during the exam session at the end of the semester or the September session or evaluation organized during the semester.
